

PHST CPT recruitment - final assessment score distribution

The graphs within this document show the distribution of interview scores for PHST recruitment since 2013.

The scores are recorded for each candidate attending an interview, including those that were found not to be appointable.

All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here. See the pages below for the number of candidates, including the percentage of those deemed appointable and non-appointable, interviewed in each round of recruitment; the range of scores obtained and the mean and median scores achieved across all candidates.


Where details for a specific year or round are not included, this should be taken to mean that the specialty was not participating in a particular round, had not yet joined the nationally-coordinated recruitment process, or there were an insufficient number of candidates to display scores.



The graph below shows the distribution of final assessment scores awarded to **clinical pharmacology and therapeutics** candidates assessed at interview in PHST 2025 ST4 recruitment round 1.

All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was **4**; the split of appointable vs not-appointable assessments was **100%**: **0%**. Scores ranged from **71.3** – **89.70** (min and max possible were 16-100). Mean and median averages achieved were **81.90** and **83.30** respectively.






The graph below shows the distribution of final assessment scores awarded to **clinical pharmacology and therapeutics** candidates assessed at interview in PHST 2024 ST4 recruitment round 1.

All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was **9**; the split of appointable vs not-appointable assessments was **67%**: **33%**. Scores ranged from **42.8** – **83.2** (min and max possible were **16-100**). Mean and median averages achieved were **70.27** and **75.20** respectively.



All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was 4; the split of appointable vs not-appointable assessments was 50%: 50%. Scores ranged from 49.1 – 84.90 (min and max possible were 16-110). Mean and median averages achieved were 68.38 and 69.75 respectively.



All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was 13; the split of appointable vs not-appointable assessments was 77%: 23%. Scores ranged from 51.9 – 98.30 (min and max possible were 16-110). Mean and median averages achieved were 81.79 and 87.90 respectively.

All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.


The number of applicants receiving a full assessment and final score was 2; the split of appointable vs not-appointable assessments was 50%: 50%. Scores ranged from 47.9 – 80.95 (min and max possible were 16-110.3). Mean and median averages achieved were 64.43 and 64.43 respectively.



The graph below shows the distribution of final assessment scores awarded to **clinical pharmacology and therapeutics** candidates assessed at interview in PHST 2022 ST4 recruitment round 1.

All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was **12**; the split of appointable vs not-appointable assessments was **58%**: **42%**. Scores ranged from **37.05** – **99.40** (min and max possible were 16-110.3). Mean and median averages achieved were **74.92** and **83.43** respectively.






The graph below shows the distribution of final assessment scores awarded to **clinical pharmacology and therapeutics** candidates assessed at interview in 2020 ST3 recruitment round 2.

All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was **14**; the split of appointable vs not-appointable assessments was **86%**: **14%**. Scores ranged from **42.3** – **78.2** (min and max possible were 16-100.4). Mean and median averages achieved were **63.43** and **63.75** respectively.






Due to the unprecedented circumstances surrounding the outbreak of COVID-19, the decision was made to cancel all remaining face to face interviews. This led to a revised scoring process being implemented which consisted of ranking candidates based on five domains from the self-assessment score that is used on the application form. Please note that the Final Score data and graphs for ST3 2020 R1 are reflective of the revised scoring process and thus should not be used to compare data in previous years. This scoring process was implemented as a result of the circumstances and therefore will not provide consistencies with data in previous years

The graph below shows the distribution of final assessment scores awarded to **clinical pharmacology and therapeutics** candidates assessed using the revised scoring process in 2020 ST3 recruitment round 1.

The number of applicants receiving a full assessment and final score was 12; the split of candidates who have met the threshold vs candidates who have not met the threshold was 42%: 58%. Scores ranged from 16.4 – 45 (min and max possible were 1-48). Mean and median averages achieved were 28.68 and 27.70 respectively.






The graph below shows the distribution of final assessment scores awarded to **clinical pharmacology and therapeutics** candidates assessed at interview in 2019 ST3 recruitment round 1.

All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was **14**; the split of appointable vs not-appointable assessments was **86%**: **14%**. Scores ranged from **33.10** – **91.05** (min and max possible were 16-100). Mean and median averages achieved were **69.96** and **72.13** respectively.



All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was 4; the split of appointable vs not-appointable assessments was **86%**: **14%**. Scores ranged from **49.25** – **95.05** (min and max possible were 16-100). Mean and median averages achieved were **68.98** and **68.25** respectively.



All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was 4; the split of appointable vs not-appointable assessments was **100%**: **0%**. Scores ranged from **61.20** – **75.00** (min and max possible were 16-100). Mean and median averages achieved were **70.44** and **72.78** respectively.



All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was 3; the split of appointable vs not-appointable assessments was **100%**: **0%**. Scores ranged from **70.95** – **89.05** (min and max possible were 16-99.5). Mean and median averages achieved were **82.42** and **87.25** respectively.



All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.

The number of applicants receiving a full assessment and final score was 3; the split of appointable vs not-appointable assessments was 67%: 33%. Scores ranged from 56.35 – 71.15 (min and max possible were 16-99.5). Mean and median averages achieved were 65.72 and 69.65 respectively.



All scores here have been rounded to the nearest whole number; and only those candidates who received both a score for their verified application form and performance at interview have been included here.


The number of applicants receiving a full assessment and final score was 5; the split of appointable vs not-appointable assessments was **60%**: **40%**. Scores ranged from **35.1** – **86.4** (min and max possible were 16-99.5). Mean and median averages achieved were **59.58** and **58.4** respectively.





The graph below shows the distribution of final assessment scores awarded to CPT candidates assessed at interview in 2015 ST3 recruitment round 1.

The number of applicants receiving a full assessment and final score was **4**; the percentage of appointable assessments was **100**%. Scores ranged from **70.45 – 79.95** (min and max possible were **16**-99.5). Mean and median averages achieved were **76** (76.00) and **76.80** respectively.




2014 ST3 Recruitment – final assessment score distribution (round 1)



The graph below shows the distribution of final assessment scores awarded to CPT candidates assessed at interview in 2014 ST3 recruitment round 1.

The number of applicants receiving a full assessment and final score was **7**; the split of appointable vs not-appointable assessments was **86%**: **14%**. Scores ranged from **58.05-83.4** (min and max possible were **16-99.5**). Mean and median averages achieved were **73** (73.37) and **74.1** respectively.




2013 ST3 Recruitment – final assessment score distribution (round 1)

The graph below shows the distribution of final assessment scores awarded to CPT candidates assessed at interview in 2013 ST3 recruitment round 1.



The number of applicants receiving a full assessment and final score was **13**; the split of appointable vs not-appointable assessments was **69%**: **31%**. Scores ranged from **46.85** – **89.15** (min and max possible were **16**.0-99.5). Mean and median averages achieved were **71** (70.86) and **76.45** respectively.



2013 ST3 Recruitment – final assessment score distribution (round 2)

The number of applicants receiving a full assessment and final score was **5**; the percentage of appointable assessments was **100**%. Scores ranged from **73.55 - 84.75** (min and max possible were **16.0-99.5**). Mean and median averages achieved were **80** (79.53) and **80.2** respectively.
